Access to site	You will be able to access the field from 8.30am. On arrival please report to the headquarters tent who will let you know where your pitch is located.
	Please ensure your pitch is set up by 11.00am at the latest. The showground itself opens to the public at 11.00am and you will not be permitted entry to the field to set up after this time due to the Carnival procession and general public arriving.
	Vehicles are not permitted to move during the day except by prior arrangement with the Bookings Secretary. Movement at any time of vehicles will be strictly controlled and you must <u>drive slowly with hazards on</u> and follow the direction of marshalls.
Parking	You will be able to park your car near your pitch to set up. You will be advised where to park by marshalls. Other cars should be moved to the general car park area on the field.
Car parking passes / admission	Your pitch booking fee allows you personally free admission to the day and also for the designated number of helpers notified to you by the Bookings Secretary. If you do not have a car or person pass you will have to pay to enter the field.
	Please advise the registration number of the vehicle you are bringing by Friday, 7 June . A car pass and person pass will be sent to the address provided on the booking form. If you need more passes please contact us as soon as possible.
	General admission is £6.00 for adults; £2.50 for children aged 5 to 16; children under 5 have free admission; Family tickets (two adults and up to three children) are £15.00. Car parking on the field is charged at £2.50 per car in addition to the entry price. Discounted price advance tickets will be available.
Payment and documentation	As part of your booking application we require a copy of your risk assessment, a copy of your PLI certificate (which must be valid for the date of the Carnival and have a minimum liability of £1,000,000), and payment for your pitch. If you wish to be included on our PLI cover for the day please include the £10 payment with your pitch booking fee. If payment and documents have not been received by 10 June 2019 your booking will not be confirmed and you will not be allowed entry to the field. Bookings are not
	confirmed until all requested documentation and payment is received.
	Please note that in the unusual event that the show is cancelled due to exceptional circumstances, the Amesbury Community Group Carnival regrets it is unable to issue a refund
	Applications without a valid name, address and telephone number will not be accepted. Acceptance of a pitch application form is not guaranteed and it may be presented to the
	Carnival Committee for consideration before your booking is confirmed. The Carnival Committee reserves the right to refuse admission or participation in this event for whatever reason.
Cancellations	A 50% refund will be made for cancellations received 30 days before the Carnival date. The carnival is unable to offer any refund for cancellations received after 15 May 2019.
General notes	Please note, that unless you have booked a catering pitch you will not be permitted to sell refreshments of any kind on your stand. You may be asked to leave if you are found to be selling such items. Catering concessions pay a premium pitch fee to attend the carnival.
	Exclusivity: We do not offer exclusivity for any type of business (not including catering concessions). Participation is a business decision for the pitch holder. Pitches: Pitches are 5m x 5m (unless extra space is purchased). Please ensure you stay within the boundaries of your pitch. No equipment is provided by the organisers for your pitch. The Carnival Committee will take in to consideration all requests for pitch location
	but cannot guarantee that this will be possible. Your allocated location on the day is not negotiable.

	Rubbish: please make sure you keep your pitch area clean and tidy during the day and when taking down your stand.
